- 1 **GO TO THE RIGHT PLACE** Contact your city office if you are unsure where to vote.
- 2 **BRING I.D.** You can register at the polls with your driver's license or another photo ID, or a current utility bill.
- 3 **MAKE SURE YOUR VOTE IS COUNTED** Get a ballot even if your name is not on the list. Ask for help from a poll worker to make sure your vote is counted.
- 4 **WHAT IF THERE IS A LINE?** You probably won't have to wait too long. Even if the line is long, don't leave without voting!
