**GO TO THE RIGHT PLACE** Contact your city office if you are unsure where to vote.

**BRING I.D.** If you are not registered, you can register at the polls with your driver's license or another photo ID, a current utility bill or a registered voter who will vouch for you.

**MAKE SURE YOUR VOTE IS COUNTED**  
 Get a ballot even if your name is not on the registered voter list. Ask for help from a poll worker. If there is a line, you won't have to wait too long. Don't leave without voting!
